Last Post, Reveille, Rouse, Long Reveille, Naval or Charlie Reveille

Courtesy of Roger Carter, please read with interest the confusion surrounding the use of the above at services, funerals, commemorations and other Veteran events.

Last Post, Reveille, Rouse, Long Reveille, Naval or Charlie Reveille? Who really knows which one should be played or sounded and when? I thought I had some idea, after all I have been around the military music scene for some time, but when an old friend contacted me and asked a simple question, I thought I'd better do a bit of checking myself to find out the truth. Me ole kiwi mate, Alastair, has successfully started Dawn Services on Anzac Day in Poona, a happy little coastal village in the Great Sandy Straits up in Queensland, and his simple question was, should he play Reveille or Rouse at the Dawn Service.

Being the clever bugger that I am, I quickly checked the internet but became more confused the further I went into it. I realised that for the past, well a long time anyway, I had believed that the Rouse was Reveille, and in the NZ Army we had sounded Rouse for Reveille!! Confused??.....so was I, so off to the big city I went. It took all of five seconds to find a park in the manager's slot at the Tasmania RSL Headquarters, and shortly I was in the possession of a recorded disc which gave me the Australian Government Department of Veterans Affairs official version of music for Anzac day etc. On the disc is recorded the Last Post, One Minutes Silence (yes!!!) The Rouse, and Advance Australia Fair. All very good, but what did they call Rouse. A quick play back confirmed that Rouse is what I had always thought was Reveille. The manager chappie confirmed that that is what he has always played and no one has ever complained.

With these words of wisdom ringing my ears, I then stopped off at the headquarters of the Australian Army Band Tasmania and the RAN Band Tasmania. Finding an easy park in the No Parking Zone, I consulted the two regular force matelots; as the two army musicians were not in..... probably out running, or

on stand down from a late night in the mess. The navy guys, one of them a brilliant trumpeter, informed me that they have played both Rouse and Reveille at different times but had no idea what time of day each call should be played.

Now I did know that Rouse is shorter than Reveille and I, like many others, have also called Reveille the Long Reveille but also calling Rouse, Reveille. Armed with this enlightenment I recalled the first time that I had heard the Long Reveille. I was in Singapore with Denis Dewe's great little battalion band. We had come down from Malacca to be the duty band for a month and on the 4th and 5th of April 1966 we played at a couple of funerals for two British soldiers who had drowned in Borneo. Both bodies had been in the water for a long time, so because of the lack of refrigeration and the resultant stench, the graveside internments were hurried along. Imagine our dismay when an old, unshaven, overweight, grubby looking British staff sergeant ambled out with a bugle and attempted to sound the Long Reveille after blundering through the Last Post. Reveille goes on for nearly a minute, compared to 16 seconds for the Rouse. I am sure that this old staff sergeant must have taken three minutes to play his version of the Reveille as he kept miss pitching notes in nearly every bar and decided to correct his mistakes on the spot.

I think that was the critical time in the history of music in the NZ Army, when the "smart kiwis" decided that they should never play the Reveille but stick with the much shorter Rouse and call it Reveille!

Now to confuse me further I discovered that the navy has its own Reveille, which is a lively tune consisting of three repeated eight bar stanzas in three eight time. I believe that it is used for calling all Hands, and follows Last Post at Naval Funerals.

An official NZ site giving advice to the citizens of Turkey on Anzac Day says that after the Last Post has been sounded "the bugler plays Reveille to signal the end of the silence and announce the beginning of the day." It goes on to say that at the "Lone Pine and Chunuk Bair service, the Last Post is followed by one minutes silence. The bugler then plays Rouse (if an Army Bugler) or Reveille (if a Navy bugler) to call the soldier's spirits to arise."

This proves to me that the army is still using the much easier and shorter version (clever scoundrels), but does the NZ Navy sound the Naval Reveille sometimes called the 'Charlie' Reveille......whoever Charlie was or is?

Several Australian sites give details on which calls should be sounded, and British Army Bugle Calls authority gives three possibilities. They say that after the Last Post and a minutes silence you can play either: the Rouse, the Long Reveille or the Naval Reveille.

Over the past twelve months or so, many fine friends have sent me a film clip of a 13 year old girl called Melissa Venema (she is now 16) playing Il Silenzio accompanied by the Andre Rieu Orchestra. For the last time this is not the Last Post. It is a piece of music made famous by trumpeter Nini Rosso, and became a world wide hit in 1965. It was later covered by a top Maori vocal group in Auckland who put words to it, and later by the RNZIR Band of 1980 -82 who featured their fabulous singers and the golden sound of Butch Green on trumpet. Hmnn I wonder who their bandmaster was? Il Silenzio is based on the American bugle call Taps, and was put together during the American Civil War in 1862.

There must be hundreds of bugle calls and many have words to them, some jovial and some downright rude, as is the custom of servicemen all over the world. And finally, bugle calls should always be played on a Bb bugle and are sounded not played.

NZDF Medal Update

Applications for the NZ Defence Service Medal (NZDSM) are expected to open in early April 2011 for the oldest ex-Service persons. Applications can only open after Her Majesty The Queen has approved the Royal Warrant, and the Governor-General has signed the Regulations.

The proposed design of the medal has been finalised by the Herald of Arms Extraordinary and will be sent to The Queen shortly for approval. Manufacturing will occur once the design has been approved by The Queen.

Around 160,000 personnel qualify for the NZDSM and the Defence Force Medals Office expect to issue around 116,000 medals over the next three years. With such high numbers a priority programme is necessary and the Minister of Defence has directed that the priority will be:

- 1. Those living ex-Service personnel over the age of 70
- 2. Those living ex-Service personnel over the age of 60
- 3. Then other living ex-Service personnel.

Terminally ill ex-Service personnel will be given priority over all other applicants but will still need to apply in the usual manner.

Families of deceased ex-Service personnel will be invited to apply for their late relation's (husband/father/mother etc) medal entitlement after the processing of the initial applications from older living ex-Service personnel is well underway, possibly in late 2011.

An initial NZDSM presentation will be made to a selected group of ex-Service personnel at a ceremony in Parliament in the first half of 2011. For logistical reasons it is anticipated that the majority of these personnel will be drawn from the Wellington area.

Regional medal presentations will be arranged by local RSA branches from late May 2011.

Interviews are currently taking place for additional staff to process the medal applications.

The hard copy form has been tested and the online version of the form is currently under construction.

For further information please read the NZDSM FAQ sheet http://medals.nzdf.mil.nz/nzdsm/faqs.html which is being updated regularly basis in line with questions received through the medals site.

Once the application process opens the Medals Office aim to deliver medals to those entitled to receive them as quickly as possible and will be providing frequent updates about the NZDSM Project on the website at medals.nzdf.mil.nz



Navy proud to celebrate Auckland's Anniversary birthday celebrations

The Royal New Zealand Navy's newest Offshore Patrol vessel, HMNZS WELLINGTON has the honour to be the guard ship for the 171st Auckland Anniversary Day Regatta.

This honour has been bestowed on a naval vessel since the 1860's. In 1862 HMS Miranda and Fawn, stationed in New Zealand, were present at the regatta in Auckland Harbour after the conclusion of the Taranaki War(1).

Between the 1860s and 1920s the presence of a naval vessel was sporadic and it wasn't until the development of the New Zealand Division of the Royal Navy in 1921 that the navy's involvement was more consistent.

This year, HMNZS WELLINGTON will be the 'Start Ship' for the races and will be anchored off Bean Rock. Onboard the ship will be The Governor General Sir Anand Satyanand hosted by Commodore Ross Smith, Maritime Component Commander.

Also, as part of this year's Auckland Anniversary Birthday Celebrations and Regatta, HMNZS WELLINGTON will be open to the public.

ISAF investigation confirms NZSAS fired in self-defence

14 January, 2011

An investigation by the NATO-led International Security Assistance Force and the New Zealand Defence Force has confirmed that New Zealand SAS soldiers fired in self-defence in a joint NZSAS and Afghan operation in Kabul on Christmas Eve.

Video footage of the operation shows that the New Zealanders were fired upon first, says Chief of Defence Force Lieutenant General Jerry Mateparae.

Lieutenant General Jerry Mateparae says varying accounts were reported of what should have been a relatively straightforward "cordon and search" operation late on the night of 23 December. The NATO-led International Security Assistance Force (ISAF) has Full Motion Video of the events of that evening. This shows that the New Zealanders came under fire first.

The video imagery has not been released by ISAF because of its security classification, but Lt Gen Mateparae has viewed the footage as part of an internal NZ Defence Force review of the operation and agrees with ISAF's conclusions. As part of a review process Lt Gen Mateparae has thoroughly considered

operational and legal aspects related to this operation and he says he is entirely satisfied the NZSAS carried out this operation appropriately.

The joint New Zealand and Afghan operation had been tasked at short notice by ISAF after credible intelligence was received about an imminent rocket and/or explosives attack on the US Embassy in Kabul. Lt Gen Mateparae says that the Afghan authorities had been alerted and approval for the Afghan Crisis Response Unit (CRU) participation had been gained. The New Zealand unit was appropriately tasked, and partnered with the CRU.

Lt Gen Mateparae says that as the New Zealanders were in uniform and as they approached the compound they clearly identified themselves as ISAF forces.

"The video imagery has captured the heat plumes from weapons as they are fired," he says. "It clearly shows the New Zealanders came under fire from an Afghan 'security guard' and that the New Zealanders only returned fire in self defence because they were at risk of death or serious injury. The guard was wounded during the exchange of fire and then retreated into a nearby building."

The video imagery goes on to show two further Afghan security guards armed with AK 47 weapons running into the compound and taking up firing positions metres away from members of the NZSAS.

"The New Zealand forces yelled a command for the Afghans to stop. Because they were in immediate danger they then returned fire at the two Afghan security guards, which resulted in their deaths. The video imagery shows what appears to be a heat plume coming from one the security guards weapons, indicating that at least one of them opened fire at close range on the New Zealanders before they returned the fire."

Lt Gen Mateparae says in total the time elapsed from the first shot being fired to the last was just 37 seconds. He says that after this exchange of fire, the NZSAS cleared nearby buildings. A NZSAS medical officer immediately gave medical treatment to the wounded Afghans. The weapons of both the dead Afghan guards were checked and both weapons were found to be loaded with a round chambered in each weapon – establishing the security guards' ability to open fire on the NZSAS members. In addition, items consistent with the initial intelligence report were found in the compound, further validating the operation.

Lt Gen Mateparae says he has been advised that ISAF do not intend investigating this operation any further because they are more than satisfied that the NZSAS acted appropriately.

"The video imagery is consistent with the version of events given at the time by members of the NZSAS. Having reviewed the circumstances I am satisfied that members of the NZSAS responded with discipline, professionalism and courage to the threats they faced," says Lt Gen Mateparae.
