### ANZAC Day 2009

ANZAC Day in 2009 will more than likely be the same format as this and previous years with descendents marching with us. However, just to clarify, the term 'veteran' in today's context refers



to all serving and ex-service personnel not just those that served overseas. So whether you have a medal or not, as long as you served in the military you are considered a veteran and I would be very privileged to march alongside you at ANZAC Day every year. Furthermore, both the Parade Marshall and I will be more controlling next year so that Veterans are at the front of the contingent with descendents behind and any other matters that need addressing based on your feedback.

### The NZ Regular Force Cadets

During the period of the "Cold War" between 1948 and 1991, an average of over 5000 New Zealand boys vied each year for entry into the Army's elite RF Cadet School or the "Club" as it was colloquially known. Less than 3% of those who applied to join, made the grade. The



Army accepted them as young as 15 into its ranks offering continued education, trade training and apprenticeships. Most would go on at age 18 to become the backbone of the New Zealand Army serving with distinction in Korea, Borneo, Malaya, Vietnam, Bosnia, Afghanistan, East Timor, Iraq and other regions of conflict as Senior Non - Commissioned Officers (NCOs). A few would earn commissions as officers. Some went on to serve with the SAS and as key personnel of other Regular Force units.

Today they can be found in leadership roles in all aspects of business, social services, government and politics following their successful careers in the Army and other arms of the services, both at home and abroad. Coinciding with the end of the cold war the School closed its doors in 1991.

### WW2 Veteran Story - Janet's Contribution



### The Last Post

Dear veterans,



Please note the passing of another veteran. As noted Jim was the founder of the NZ Army Band and what a spectacular history they have:

The history of the NZ Army Band starts in 1957 with Battalions Bands. These bands were normally made up from Infantrymen who had some musical

background, and it was the task of each unit Bandmaster to meld this collection of individuals into an efficient musical group.

It wasn't until 1964 that the band became fully professional with the recruitment of experienced musicians. Potential recruits coming from the amateur Brass Band Association and the idea of a professional Band was a new concept for most Bandsmen in New Zealand.

From 1965, members of the New Zealand Army Band were frequently posted to the Band of the 1st Battalion, Royal New Zealand Infantry Regiment, in Singapore. This began the biannual postings between Singapore and New Zealand that would continue until December 1988, when the 1 RNZIR Band was disestablished and members returned to the New Zealand Army Band.

Throughout the New Zealand Army Band's history, it has played an active role for many illustrious occasions. These include participation in both Commonwealth Games held in New Zealand, Christchurch in 1974 and Auckland in 1990, the VI

Day 50th Anniversary celebrations in 1995 and a featured performance at the Edinburgh Military Tattoo at Wellington's Westpac Stadium in 2000. Such events were in addition to performing at official welcomes for foreign dignitaries at Parliament, at official engagements at Government House and at international sporting events.

A popular destination for the New Zealand Army Band has been Australia, with the 1988 Bi-Centennial Tattoo repeat visits to the Brisbane Arts Festival Tattoo, the Perth Royal Show and the Great ANZAC Military Tattoo in Sydney. In 1991 the Band went to Greece and Crete to commemorate the 50th Anniversary of the Battle of Crete, and in 1995 travelled to Washington DC to participate in the unveiling ceremonies of the Korean War Memorial. More recently the band travelled to Wonju, Korea to participate in the Wonju Tattoo, which featured military bands from ten countries.

2002 saw the NZ Army Band perform at the Edinburgh Military Tattoo and has since performed at the Edinburgh Military Tattoo - A Salute to Australia 2005 in Sydney, Australia. In August this year, the NZ Army Band will be performing again as guest band of the Edinburgh Military Tattoo in Scotland.

The NZ Army Band is an important part of the NZ Army culture and heritage, and is renowned for its professional attitude and high standards. It continues a tradition of excellence wherever it goes.

### Commendations for Malaya Veterans

NZ's oldest Army Regiment celebrates 150 years service

The 5th Wellington West Coast Taranaki Battalion Group (5WWCT) crest. See below for history of the crest.

New Zealand's oldest Army unit the 5th Wellington West Coast Taranaki Battalion Group (5WWCT) marks its



150th year of service to New Zealand this weekend with a series of activities in New Plymouth and around Taranaki.

The celebrations will begin with a Chunuk Bair remembrance dawn service at the Malone Gates in Stratford this Friday morning, followed by a parade through the streets of New Plymouth on Saturday. The celebrations finish on Sunday with a service in St Mary's, New Zealand's oldest stone church, and where the regiment was garrisoned for short time in 1860.

The charter parade, accompanied by the sounds of blank gunfire, will receive a challenge from the NZ Police as they reach the Puke Ariki Landing where the Charter will be re-affirmed to allow the regiment to march through the streets with swords drawn, drums beating, bayonets fixed, and colours flying. This parade commences at 1:30pm.

During the parade a number of the Regiment's personnel will be presented with medals for deployments to the Solomon Islands and Sinai as well as efficiency medals.

A powhiri will be held at Owae Marae in Waitara to recognise and acknowledge the presence of the Regiment to Iwi in the Taranaki area. The powhiri will be on the 8th August, commencing at 1:00pm.

"It is very important for us to continue our relationship with the people of the area, with whom we now have had a long relationship, and one which we need to recognise alongside our own history," said Warrant Officer Class One Kenny Trinder.

Major Simon Strombom, the Regiments training officer, is continuing the tradition of his family's military service which began in Taranaki and is currently serving in Afghanistan. Major Strombom says he will be thinking of the province and of the regiment this weekend.

"It would mean a lot to be back in the province with the unit in its 150th year where so much of my family history is tied to. I will be thinking of home when the unit parades."

### Navy Frigate heading to Wellington

The first of the Navy's ANZAC Class frigates, HMNZS TE KAHA, will arrive in Wellington on Wednesday 20 August and depart on Monday 25 August at 10.00am.

HMNZS TE KAHA has recently been engaged in maintenance on the various systems on board that enable the ship

to fight, move and float. TE KAHA is now enjoying a relatively rare opportunity to visit ports in New Zealand before deploying to South East Asia and Australia later next month.

In Wellington, the ship will host various guests on board including the following:

- On Wednesday 20 August at 0945 there will be a 21 Gun Salute from the Maritime Component Commander as a mark of respect to the Governor General as the ship rounds Point Jerningham.
- On Friday 22 August at 9.00am, members of the media are invited on board for a ship's tour and a question and answers session with the Executive Officer, LT CDR Wayne Andrew.

### HMNZS Te Mana leaves Arabian Gulf

### HMNZS TE

MANA has departed her area of operations in the Southern Arabian Gulf and is making her way back to New Zealand.

Over the past three months the frigate and her 173 strong ship's company have reported more than 1700 vessels in the area, and carried out 228 approach and assist visits in support of maritime support and security operations for Coalition Task Force (CTF) 152 in the Central and Southern Arabian Gulf.

Commanding Officer of HMNZS TE MANA, Commander Blair Gerritsen said that the whole team feels a great deal of satisfaction in having played a part in the multinational effort to restore peace, stability and a sense of normality to an area which has seldom seen this.

"Denying the influence of those who pose a threat to the security of the Arabian Gulf's waters whilst protecting the legitimate mariners who operate throughout the area has been a challenging but satisfying task. My ship's company can take a great deal of pride in the professionalism, endurance and good humour that they displayed over a prolonged period in trying conditions."

The Kiwis have also been praised by the multinational partners in the Gulf.

"Many of those we have worked for and with in CTF 152 are staggered that such a small Navy could make such a significant contribution to an operation so far from home," said CDR Gerritsen.

HMNZS TE MANA is expected to return to New Zealand on 7 September.

### Air Force Boeing 757 returns to NZ skies



B7571, the RNZAF's upgraded and modified 757 arrives in Wellington (OH08-0454-01).

In what is a major milestone

for the Ministry of Defence (MoD) and the Royal New Zealand Air Force (RNZAF) Boeing 757 modification and upgrade programme, the first of two aircraft (NZ7571) has returned to New Zealand from Mobile Aerospace Engineering in Mobile, Alabama.

After 16 months of extensive airframe and avionics (navigation/communication) modifications, the 757 touched down at the RNZAF's Airmovements Terminal in Wellington this afternoon for its official welcome.

On hand to greet the aircraft and crew were the Minister of Defence, the Honorable Phil Goff, Secretary of Defence, John McKinnon, Chief of Defence Force, Lieutenant General Jerry Mateparae, Chief of Air Force, Air Vice-Marshal Graham Lintott, invited dignitaries, and regional Defence personnel.

"To see the first Boeing arrive back in New Zealand is a reward to all those involved in this project. The increased capability of this aircraft will provide a significant boost to the Air Force's airlift options. We will have the ability to rapidly change the role of the aircraft to any given task, converting from standard passenger configuration to a combination freight/passenger, full freight, Aero Medical Evacuation (AME) and VIP set up," Air Vice-Marshal Lintott said.

The aircraft will conduct Introduction into Service activities over the coming months including training, operational testing and evaluation of the upgraded B757 air transport system as a whole. It is expected to be ready for operational tasking before the end of the year.

The second of the RNZAF's Boeing 757 aircraft will complete its upgrade programme at Mobile Aerospace Engineering and Boeing Integrated Defence Systems in Wichita, Kansas towards the end of the year. Both modified 757 aircraft will be fully operational and available from early 2009 after completing Operational Testing and Evaluation in New Zealand.

The \$221 million dollar acquisition and modification project commenced in May 2003 when the RNZAF replaced its aging Boeing 727 aircraft.

### RNZAF Iroquois to tackle mountains

The skies

around Marlborough, Molesworth, St Arnaud and Dip Flat will soon be humming with the sound of Royal New Zealand Air Force Iroquois helicopters taking part in Exercise Blackbird. The mountain flying exercise from 4 -15 August will involve five Iroquois and nearly 140 personnel, over two rotations, based at Dip Flat.

The helicopters and crews will conduct daily flights to test their skills in a low-visibility, high-altitude mountain environment, with night flying being undertaken 5, 13 and 14 August.

Detachment Commander Squadron Leader Nigel Cooper said the exercise ensured pilots and crew maintained the skills needed for search and rescue operations that often occurred in mountainous terrain, and for the uncertain conditions that could be faced when on deployment overseas.

"You need an increased awareness when you are mountain flying. The way the wind moves over the ridges and down in the gullies and valleys means it can change unexpectedly and can be a bit of a challenge. It is quite different to flying over an open field or the ocean."

The uneven terrain and snow makes landing more difficult with false horizons and whiteout, he said.

Launch of Law Commission's "Towards a New Veterans' Entitlements Scheme: A Discussion paper on a Review of the War Pensions Act 1954"

Remarks at the Launch by the RNZRSA National President Robin Klitscher at Parliament on 31 July 2008.

From the RSA's point of view, this is a momentous day. Fifty years on, we follow in the footsteps of some very capable and very accomplished people, who were veterans, and who had more than a hand in writing the War Pensions Act 1954 – the late Sir John White, for example, was one of them.

What we celebrate today could be taken to be critical of the work that they did. But that is not so. They did well for the times in which they did it, and the marvel is that what they did served so many veterans as well as it did for so long.

Over time, the nature of operations has changed. Everybody knows that. But the social and legislative framework has also changed, and it's time to accept that the provisions set so long ago are no longer in proper sync with today's conditions.

This is a very large task. It would have to be the largest task undertaken by and on behalf of veterans' organisations in more than a generation. And we are well aware of the quality of those who have gone before – like Sir John White and other RSA leaders of his day; and like the many others who have striven across the years to keep the results of their work in reasonable touch with changed needs.

I'm sure that they would approve of what we are now doing. But we also have an obligation to them to ensure that the standards they set for their times are equalled or bettered by us for our times, and for decades ahead.

Which does nothing if not emphasise how big this call really is, as we head into the 21st Century. The past has set us high standards for the future.

We of the RNZRSA and its Affiliates are pledged to play our part. We have been consulted in the development of this discussion document. I say to the veterans gathered here, however, and will say to others elsewhere in coming weeks and months, that this is not a policy document, nor is it the first draft of new law. It is what it says it is – a discussion document, designed to flush out the questions that must be answered, not to solve them at this stage. And so, what we the veterans must do is respond to those questions as honestly and as thoroughly as possible in order to get to the best answers.

This document is the start of that process. The RNZRSA will be doing its own formal response to it. So, I hope, will individuals. Indeed, Sir Geoffrey Palmer will be travelling the country in October and November in order to encourage just that. And all of this is just one step in a process that will go on well into next year as the law is prepared for tabling in the House of Representatives and the ensuing Select Committee processes. It is most important that veterans remain engaged throughout all of this.

I would like now to thank the Minister and the present Government for accepting that this needed to be done, and for setting the process in train through the Law Commission. Whatever the polls may deliver later in the year, I would hope that the processes now so energetically and productively put in hand by Minister Barker and his colleagues will continue, and will be brought to the conclusions as yet only in promise. We also thank Mr Barker for not falling into the misapprehension that Tribute08 was the end; done and dusted; everything fixed up in public; what's next? Tribute08 was certainly a part of the MoU. But only a part. I don't want to try to be Churchillian, but Tribute08 was not an end, only a beginning. That this Veterans' Entitlements Act process is now going on is evidence enough of that. And there are other important parts of the MoU that are yet to be implemented. None of us should lose sight of the fact that this is part of an ongoing process, not something that ended on the streets of Wellington in June.

I would also like to thank Sir Geoffrey for his whole-hearted embrace of this very large and complicated task. Indeed, on occasion we have had to ask him to slow down a bit so that we can keep up. And we thank him for understanding that, too.

We also thank his staff, particularly Lecretia Seales and Marion Wilson who have produced what I think is the most thorough and most informative document on the New Zealand veteran support system ever produced. It gives us a very sound foundation from which to move forward. We in the veterans' movements need now to take up the invitation it contains to ensure that the most satisfactory answers possible are achieved.

Finally I would like to thank the NZDF but particularly VANZ itself as it takes up its new shape. It must be very difficult to work for such a prolonged period under the uncertainty not only of review and organizational upheavals, but also in the shadow of changes to the legal underpinnings. The fact that the system hasn't collapsed altogether under the very heavy weight of scrutiny that has been its lot for an uncomfortably long time testifies to its fundamental soundness, and to the quality of those who are obliged to make it work. To them, in particular, we say "Thank You".
