#### William (Bill) Russell proposed Malaysian Veterans Day Presentation:

This was a "Power Pont' presentation that covered why? examples of the Korean, Vietnam and East Timor conflicts and the Malayan campaign that was never fully recognised for what it had achieved. The mission is to seek support from the NZ Government to gazette September 16<sup>th</sup> as Malaysian Veterans Day. Why that date? The advice received from the Malaysia High Commission is that the 16<sup>th</sup> September is the day that Malaysia was founded. Where to from here? The lobbying begins Veteran affairs, Minister of culture and Heritage, Minister of Defence, Minister of Internal Affairs and others. Publicity by branches to set targets to generate publicity about the Malaysian Campaign, "what was it all about" Budget for this project unsure, not sorted yet, no format finalised. After match function still to be decided.

## Matters arising from this presentation:

Mr Hemana Cliff Waaka thanked William Bill Russell for his presentation and fully supported the ethos of the project. Hemana went on to express his already many discussions that he has had with other high profile dignitaries including MP's. The membership present was also in support of this presentation and gave Bill Russell a standing ovation for his project presentation.

#### 1 NZ Regt Terendak Marae:

Mr Hemana Cliff Waaka then confirmed and supported the issue of the 1 NZ Regt Terendak Marae now based around the Linton Camp Parade Ground. This matter was raised by Mr George Kereama initially to look at forming a working group to research the back ground on this Marae and see if this can be re-established. Mr Kereama went on to back ground his own involvement in his Marae after being discharged from the Army, and what he has learnt and achieved from being involved. Mr Hemana Waaka went on to explain the background and research that he had achieved in identifying what had transpired during the dismantling of the Marae during its transitional moving from Malaysia to NZ.

It was moved by Hemana Cliff Waaka and seconded by Puke Peawini "that Mr George Kereama be the coordinator for this project"
